- ❖ Only those candidates securing 60% and above in the Higher Secondary Examination must apply. Cancellation or withdrawal of admission shall not be allowed for any admitted students. Admitted students will not be admitted afresh.
- ❖ Admission into FYUGP 1<sup>st</sup> Semester programme is subject to availability of seats.

### B. TERMS AND CONDITION FOR LATERAL ENTRY ADMISSION:

- ❖ Students seeking lateral entry admission into FYUGP 3<sup>rd</sup> Semester programme are required to apply in Samarth portal through the link <https://assadm-le.samarth.ac.in/>
  - ❖ Students seeking lateral entry admission into FYUGP 3<sup>rd</sup> Semester programme are required to enter verified APAAR ID which is mandatory.
  - ❖ Re-admission through lateral entry in 3<sup>rd</sup> Semester is not allowed in the same College or University/Programme/Department for the same Major and Minor combination of the applicant as in 1<sup>st</sup> Semester.
  - ❖ Students must have cleared the examination of the preceding semesters.
  - ❖ Lateral entry admission into FYUGP 3<sup>rd</sup> Semester programme is subject to availability of seats.

**NOTIFICATION**

In continuation of the earlier notification 639138/12 and in the greater interest of the student community and after due consultation with the Core Committee for admissions and concerned HEIs participating in FYUGP/FYIMP/FYUPGP, the undersigned is directed to notify that another round of Admission for FYUGP/FYIMP/FYUPGP will commence from 11th to 24th August, 2025 for the academic session 2025-26 **exclusively for students who were unable to get admissions to any HEI so far**. This will provide them an opportunity to enter the Higher Educational Ecosystem of the State.

Admission portal will be opened from 11th August, 2025 to 24th August, 2025 for new registration, profile correction and grant of admissions. However, following conditions are to be noted:

- a. Cancellation or Withdrawal of admission shall not be allowed for any admitted students. Admitted students will not be admitted afresh.
- b. For applicants who had applied earlier but have not yet been admitted due to awaited results of revaluation, provision will be made to enable the functionality of "edit or modify" their applications and change their 12th status for either "Appearing" or "result awaited" to "Passed" and thereby enter their marks and upload the relevant documents marksheet.
- c. Payment gateway is to be dis-integrated from the said portal for this admission session and

the mode of payment will continue in the other modes.

All Higher Education Institutions are requested to follow the above-mentioned points in granting admissions during the period mentioned above. This has the approval of competent authority.

In the larger interest of the student community, the undersigned is directed to notify that the lateral entry portal will be opened on 14th to 23<sup>rd</sup> August.2025 in <https://assamadm-le.samarth.ac.in/> with the following conditions.

1. Entry of verified APAAR ID will be made mandatory for admission through lateral entry or NEP re-entry. In case, APAAR ID is not created by the applicant, provision will be made to redirect them to the landing page to create the APAAR ID and upon successful creation, they will be reverted to the portal.
2. Re-admission through lateral entry in 3<sup>rd</sup> semester is not allowed in the same College or university/programme/department for the same Major and Minor combination of the applicant as in 1<sup>st</sup> semester.
3. Must have cleared the examination of the preceding semesters.
4. Provision for mandatory tick-boxes will be made in the portal as given below and admissions are to be granted after ensuring that these boxes are checked:
  - a. "We have checked and verified that the lateral entry applicant's percentage (combined merit score) is not lower than entry level cut-off and qualification criteria of the batch that the lateral entrant is joining."
  - b. "The lateral entry criteria of the concerned Institution (University/ Autonomous College) are checked and found to be compliant for the lateral entrant."

It is for kind information of all concerned that Lateral entry is for direct entry from polytechnics and NEP re-entry is for entry of students who have been admitted to 1<sup>st</sup> semester in FYUGP/ FYIMP/ FYUPGP and wish to continue their studies in 3<sup>rd</sup> semester in a different Institution or a different programme or different discipline combination. It is to be noted that office memorandum issued by Higher Education department vide Ecf No.255270/2024/79 dated 30-07-2024 is to be followed in addition to the Institution specific guidelines/ notifications issued in this regard for the purpose of lateral entry and NEP re-entry. This is issued with approval of Competent Authority.
