Sub : Permission for opening TDC 1st year B.B.A. and B.C.A. Course for the Session 2008-2009.

DECISION OF THE EXECUTIVE COUNCIL :

- (1) RESOLVED that the College be granted permission for opening TDC 1st year B.B.A. and B.C.A. Course for the Session 2008-2009 on receipt of prior Concurrence of the State Govt. as per G.U. Act, 1947 as amended upto date.

The College be directed to fulfil the following conditions.

- (1) To obtain Govt. Concurrence of both the Course and submit the same to the University for necessary consideration.
- (2) To proposed B.B.A. and B.C.A. Courses will run as a full time Course.
- (3) The admission will be as per the regulation for G.U. B.B.A. and B.C.A. Course.
- (4) The College will recruit atleast one MBA and two M.Com Teachers as per the UGC norms within one year from the start of the course for B.B.A. course. Initially, the existing faculty for B.C.A. programme will be sufficient for the 1st year course. However, additional faculties must be recruited in the phased manner when all the six semesters started (odd-odd/even-even).
- (5) Intake capacity will be B.B.A. - 40 and B.C.A. - 25.
- (6) The fee structure will be reasonable.
- (7) To submit compliance report to the Registrar, within 60(Sixty) days from the date of granting permission.

RESOLVED also that a copy of the Resolution be sent to :-
