The Governing Body meeting of K.C. Das Commerce College held on 30th April, 2021 in the College's premises under the Chairmanship of Prof. Amlandeep Das. President. Governing Body of the College discussed on allotment of work order to develop ERP and online admission software of the College under Agenda No. 6.

In the meeting the following resolution was adopted unanimously.

Agenda 6: Discussion and allotment of work order to develop LRP and online admission software of the College.

The Principal apprised the GB that following resolution no. 2 of the online GB meeting held on 24th March 2021 steps were taken. A tender notice was floated on 13th April 2021 (Tender no. KCDCC/TN/2021/111). Quotations were received from four firms and following assessment by the technical committee, two firms namely S. S. Technologies, Guwahati and Kareng Technologies. Guwahati were invited for presentation before the expert committee on 24th April 2021. Prof. Sanjay Singh, Head. Department of Library and Information Science, Gauhati University and Prof. Kandarpa Sarma, Head, Department of Electronics and Communication Engineering, Gauhati University were the external members. Both the firms presented their softwares in detail. Opinions were taken from each member attending the presentation. Based on the software features, technology, use of cloud server, discounted price, terms and conditions listed by the Vendor etc. the members opined that College will gain if the work is allotted to Kareng Technologies. The matter was also placed in the Purchase Committee meeting held on 261 April 2021 where the Committee preferred Kareng Feelmologies. The GB perused all the papers and expressed satisfaction at the way steps were taken. The GB accepted the recommendations of Expert Committee and Purchase Committee. Considering the upcoming new admissions and other time related constraints, the GB further directed the Principal to issue work order to Kareng Technologies immediately. The GB hoped that the upcoming LRP and online Admission Software of Kareng Lechnologies will be able to satisfy the needs of the College.
